The investment is estimated to reach the amount of 52.6 million Euros. The fundamental axis of the investment plan concerns the management of Conventional Wastes through the use of modern technologies aiming at an absolute environmental protection and according to a financially viable strategy so that the long-term implementation and operation of the project is fully ensured.

The project will be processing 105 thousand tons of wastes on annual basis through the Sewage Treatment Plan (STP), will be recycling at least 17,000 tons of appropriate materials and will be producing green energy with the capacity to satisfy the needs of 3,000 families and generate savings of 12,000 tons of CO₂.
